## **B. SYSTEM REQUIREMENTS**

ILEVR 4.0A-4.0.0 requires a computer with the following minimum hardware configuration:

- A CD ROM drive for installations and updates.

    - 1.5GB available hard disk space
  - Windows Vista Business and Windows 7 Pro (32-bit)

### New Installation

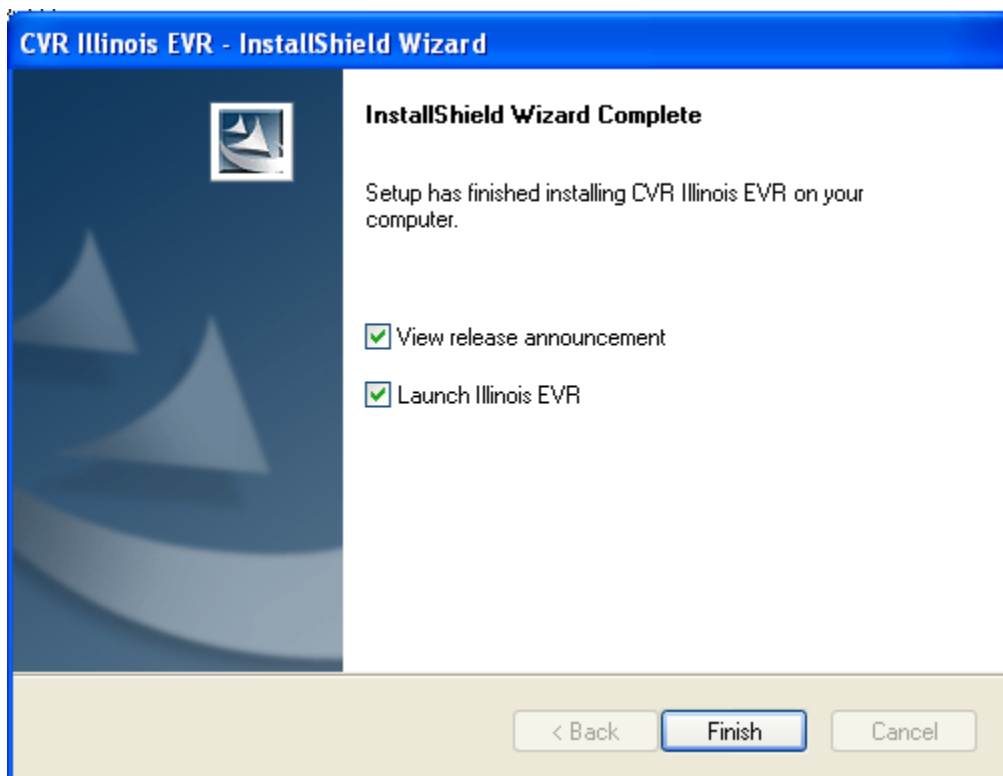
This application can be used for a New Install or for an upgrade to the new version.

During the installation process, click **Next** to accept the default setup values displayed for each of the prompts.

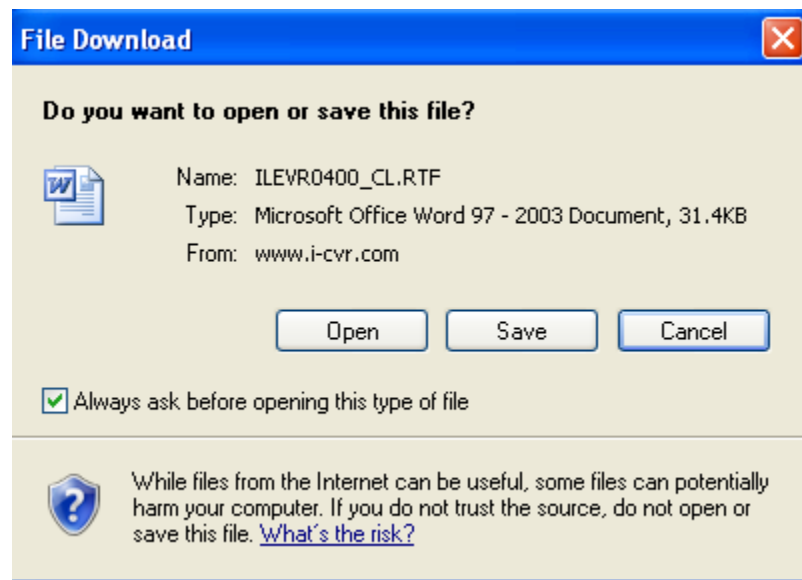
### Upgrade Installation

- Clients must be on version 3.2A or higher to upgrade to 4.0A
- All Vista installs must be clean installs to support the new Vista directory structure
- Versions prior to 3.2A will not upgrade to 4.0A
- Convert all DMS selections to XML format

Both clean and upgrade installations will display this screen last in the installation process for the user to read about the features in the release and to launch the program automatically once Finish is checked. Un-checking the box(es) will not launch the program and/or display any release announcements and the user will be returned to their PC desktop.

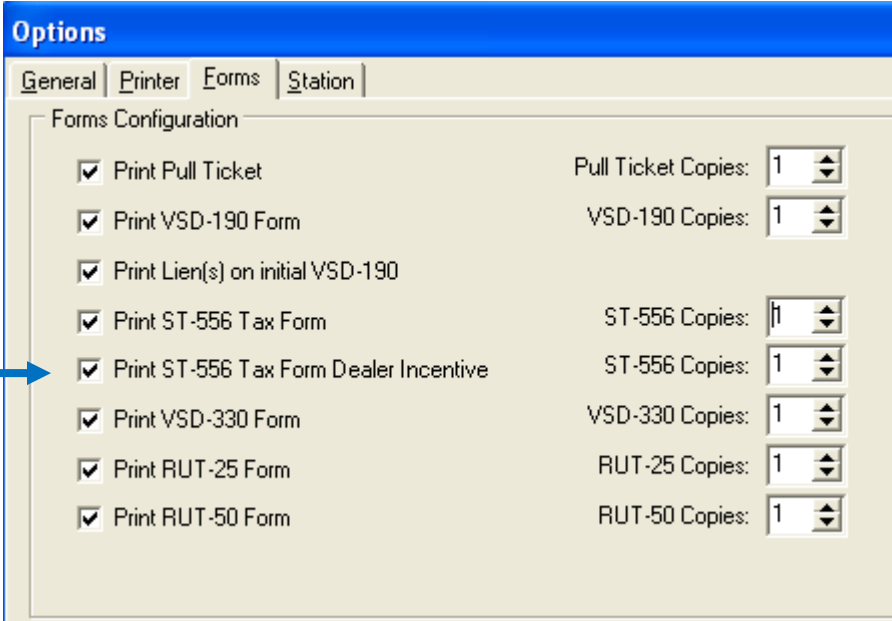

## D. ENHANCEMENTS

### 1. ADD DEALER INCENTIVE FUNCTIONALITY







A Dealer Incentive function has been added so Illinois can track and manage the amounts and applicable sales taxes within the electronic vehicle registration system. This functionality is limited to **ST-556 Sales Tax deals only**. There is a Dealer Incentive tab in the title and registration selection for In State dealers to enter the dollar amount of the incentive.

To automatically print this additional ST-556 document for any Dealer Incentive deals, you can check the form under Options > Forms and select the number of copies desired.

## 2. ALLOW REMITTERS TO PROCESS RUT-25 DEALS

The owner tab has been modified and the seller button is now enabled if the company type is Remitter. This will allow a user to record information on behalf of an Out-of-State Dealer and proper tax forms will be generated.

### 3. ALLOW REMITTERS TO PROCESS ST-556 COURTESY DELIVERY DEALS

If the company type is a Remitter, they are now able to record the name, address, IBT number, Tax Location Number, Tax Location Name ID, and Dealer Number for an in-state dealer and indicate that the deal was an in-state sale between a dealer and an individual/company. The ST-556 will print the data entered into these 4 fields on the document.

#### 4. ALLOW CONSOLIDATED DEALERS TO PROCESS RUT-25 DEALS

Illinois will now allow a Consolidated Dealer to record the name/address of an out-of-state dealer and indicate that the deal was an out-of-state sale between a dealer and an individual/company that generates a RUT-25. The seller field is now enabled for the user to enter this data.

## 5. ALLOW PLATE INQUIRY DURING IMPORT

This feature was specifically designed for rental car companies which optionally processes an inquiry with vehicles that have a license plate during an import for a transfer transaction. This function can be enabled or disabled in the Tools>Options screen. The plate and vehicle information will display on the Tag Sticker screen. The CVR fee for an inquiry will be charged for each imported deal containing a plate number.

## 6. ALLOW BATCH PROCESSING

Users can select multiple transactions from the Title & Registration list screen and transmit all of them at one time. The implemented solution will modify how the deals are completed so that the commit/abandon screen (or other related screens) displays as deals are printed in the batch. After the user acknowledges this information, all remaining deals in the batch will print Registration Certificates and other documents continuously without interaction from the user. Any deal that fails to pend or complete will not be updated and will be skipped during the printing process. After the batch has completed processing, users will be able to determine which deals encountered errors and make the necessary corrections prior to transmitting again. The user may select multiple control numbers for reprinting the documents from the Reports > Registration List. To enable the batching process you can select Tools > Options and check the Enable Batch Transmitting button at the bottom of the screen.

## 8. MODIFY REGISTRATION CERTIFICATE STICKER LAYOUT

The Illinois Secretary of State's office has requested that the layout for the printed sticker on the Registration Certificate be modified since many stickers have data partially off the sticker. The font size has been reduced and the height of the sticker number indicator moved to accommodate the sticker positioning.

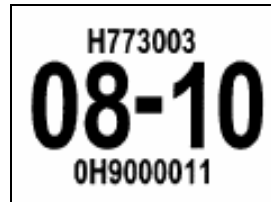

### 9. REMOVE DATA FROM REGISTRATION CERTIFICATE

The bar code has been removed, per state mandate, for the registration card.

### 10. ALLOW "TAX RETURN ONLY ST556" TO BE PROCESSED AS 2-STEP

The "TAX RETURN ONLY ST-556" deal type can now be initiated by an F&I station and completed by a Title Clerk as a 2-step transaction. All relevant reports will be printed after PEND (e.g., Pull Ticket and ST-556) and the user will be prompted to re-feed the ST-556 after the deal is completed.

### 11. PREVENT ACCESS TO INQUIRY

A setting now exists to prevent any user for a company to be able to process an Inquiry from within the product. Please contact your Account Executive to prevent access to inquiries.

### 12. ADD MOTORCYCLE TO SALVAGE DEALS

Salvage Company types can now process salvage/junk transactions for motorcycle body types.

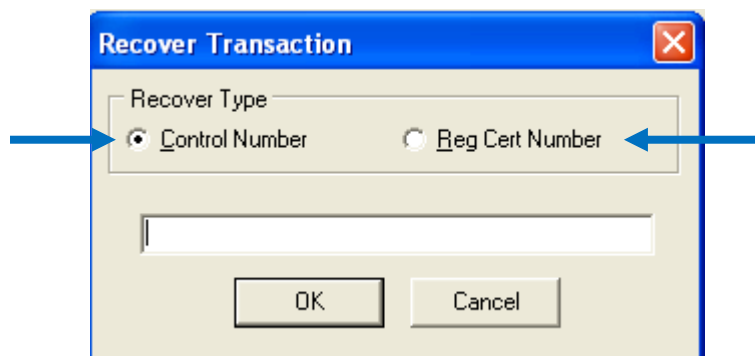

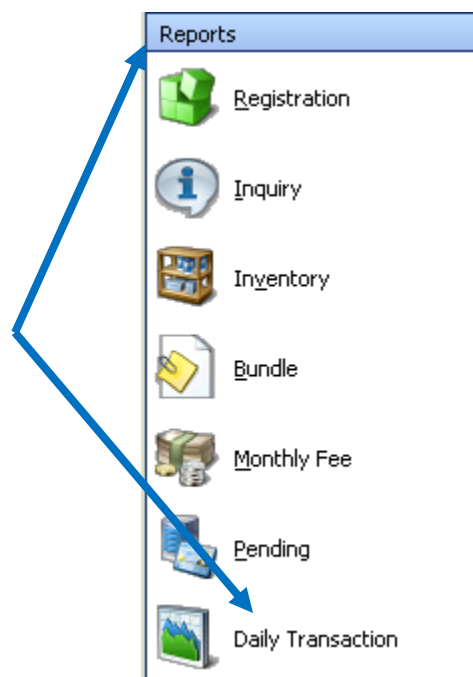
### 13. MODIFY RECOVERY PROCESS TO ACCEPT REGISTRATION CERTIFICATE

For the user to recover the correct deal there are 2 fields to select from to obtain the right information, *Control Number* and *Reg Cert Number*. Entry field is blank for data to be entered by user.



### 14. CREATE NEW "ON DEMAND" BUNDLE REPORT

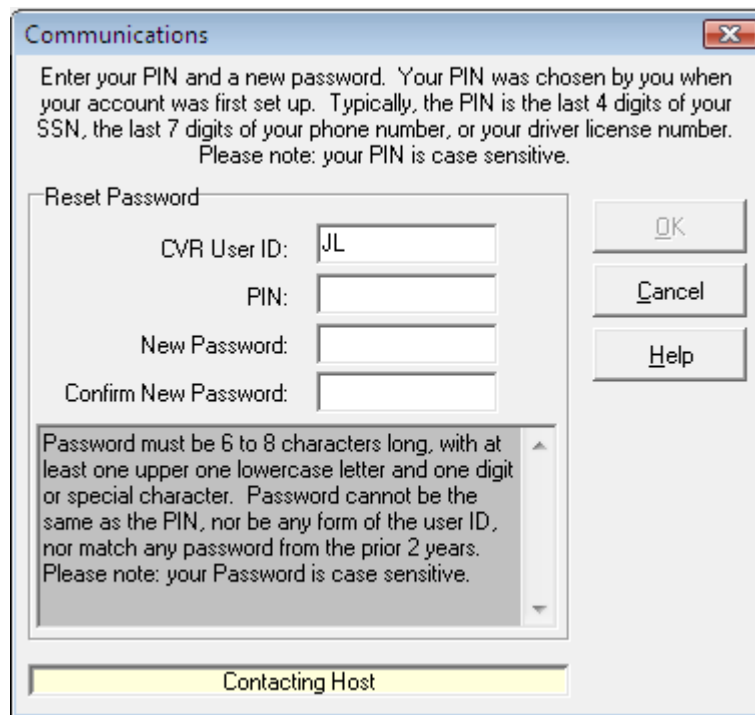
Users can obtain a bundle report for the same day reflecting all deals and monies due for that day. Select the Reports Tab > Daily Transaction and a report will display to recover all data required. This report will follow the same layout as a regular bundle report for easy field access.



### 15. ENHANCED PASSWORD RESET

Users can now update their own password by establishing a PIN number. If the user currently has a valid password they may use it until it expires. When the password expires, the user will be prompted to create a PIN number and establish a new password. When a password has been created and the user enters an invalid password 3 times they will be prompted to enter their PIN to create a new password. If the PIN is entered invalid 3 times they will be prompted to contact CVR for a password

reset. To establish the initial PIN the PIN field will be completed with 1TIME, new password and confirm new password.



**Communications**

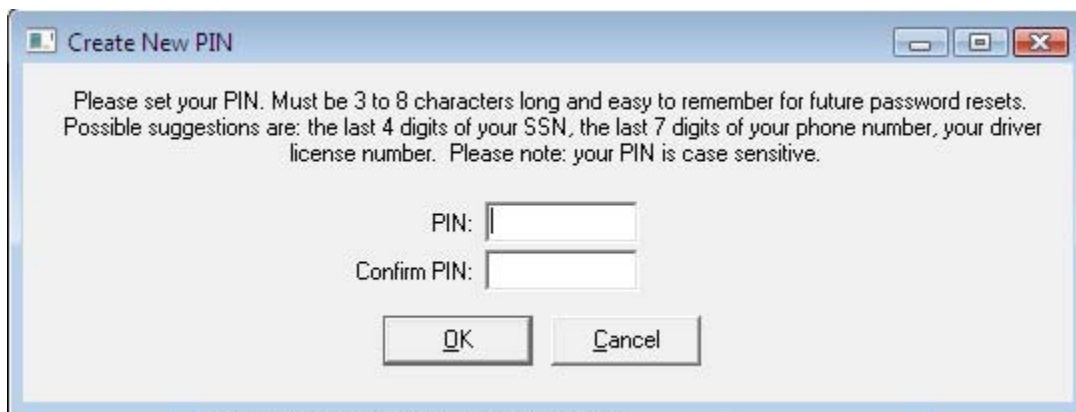

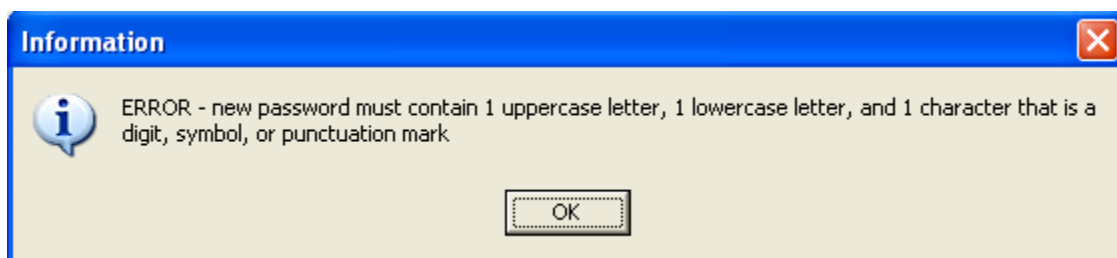

## 16. UPDATE GRAPHICAL INTERFACE

The EVR application has been given an updated graphical interface that gives a more windows look and feel to it.

## 17. ADD FILTERS TO REGISTRATION LISTINGS

Sites that process numerous vehicle sales can now search by filtering specific information on the Title and Registration List that will reflect the desired information. Example would be if a control number of REND was entered in the control field and the user clicks on "Filter", only deals with that control number would be displayed on the screen. The search criteria will remain on the screen until the user either changes the search criteria, closes the program, changes the filter button or logs into a different CMF.

## 18. UPDATE REQUIRED/OPTIONAL/DISABLED FIELDS

The ST-556 Tax Return Only screen fields have been updated to correspond with the state forms required by the Illinois DOR. Some fields are now required, optional or disabled for the user.

## 19. DECODE OWNER COUNTY FOR OUT-OF-STATE ZIP CODES

The Inventory icon will be removed from the Reports Panel. Inventory can be accessed through the Process Tab > Inventory.



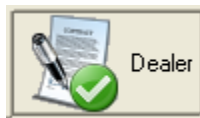

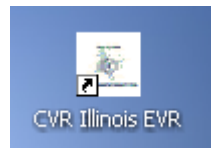

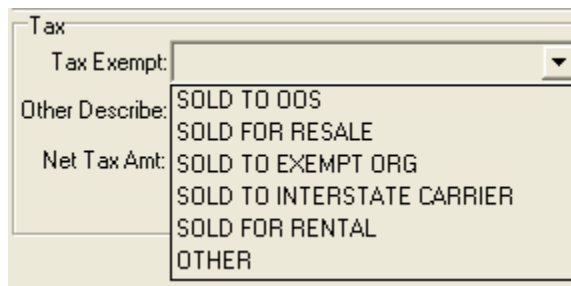

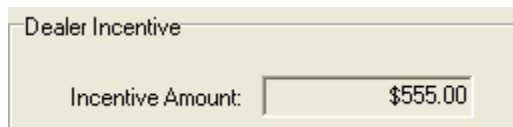

If station 1 pends a deal it will display at station 2 after overnight processing to complete. Should station 1 recover and delete this deal after overnight processing occurs it will now be deleted from station 2 the following day after overnight processing takes place.

#### 4. FIX TIMING FOR AUTOMATICALLY PRINTING ST-556 DEALER INCENTIVE

The ST-556 for a Dealer Incentive amount will printing after a deal is successfully pre-paid or completed (whichever is first).

#### 5. CLEAR DEALER INCENTIVE TAX FIELDS

When users update the Dealer Incentive Amount field to \$0.00 for a previously entered deal after it has been PENDed (but not pre-paid or REGT'd), the related tax fields will also be cleared out on the Host to ensure that the funds are not mistakenly included in the EFT totals or transmitted to the Department of Revenue.

#### 6. DISPLAY CORRECT TAX AMOUNTS ON BUNDLE / DAILY TRANSACTION REPORT

The TAX CREDIT and DLR ALLOW fields displayed on the Bundle Report and Daily Transaction Report are incorrectly including the taxable amount due on the dealer incentive value. The TAX CREDIT field will only reflect the amount recorded by the user in the Tax Credit field on the Sales tab; the DLR ALLOW field will only reflect the sum of the amounts of the Dealer's retail allowance for the tax due on the vehicle sales and the dealer incentive amount (if one exists).

#### 10. MODIFY DEALER NAME AND ADDRESS ON ST-556 SALES TAX FORM
